## Visa on arrival at IKA airport in Tehran

Getting a visa on arrival at Tehran airport is very straightforward.

### YOU NEED:

1. Passport.
2. Travel Insurance (made in advance through RJ Travel services or bought at the airport).
3. Visa grant (made in advance through RJ Travel services).

**When you get off the plane, follow the arrows that say VISA.** There is a section that leads to the passport stamp area. Don't go there. Look for the visa area under the letters "Welcome to Imam Khomeini Airport City." The entrance door is closed and opens automatically.



### Inside the Visa area

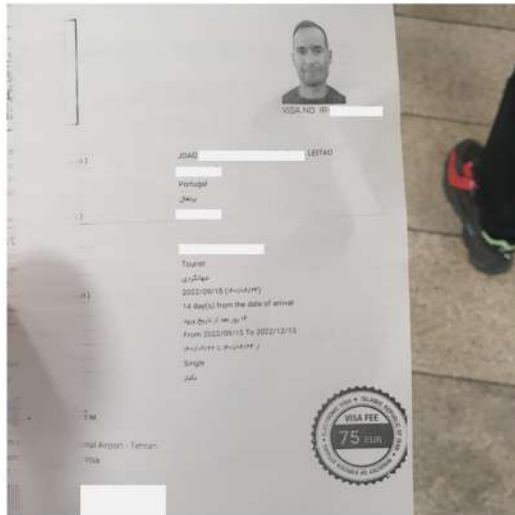
**THE PRICE OF VISA DEPENDS ON NATIONALITY. MOST EUROPEAN COUNTRIES PAY 75 EUROS / 80 USD.**

#### WHAT TO DO:

Deliver the passport with the approved visa grant to the gentleman in the window on the right.

Wait for a new visa paper.

Take the passport and new visa paper to the Bank counter on the left side.



Pay 75 euros + 3 USD bank commission (if you give 100 euros, they give change)

Return to the starting window with the new visa paper, bank payment receipt, and passport. Ask if everything is OK and if you can leave.

And, it's done. **Congratulations!**

Leave the area and return to the passport officers area and wait in line.

## Instructions at the Airport

**Passengers who have applied through [evisa.mfa.ir](http://evisa.mfa.ir)**

**Upon arrival at the airport, go through the following steps:**

1. Go to the airport bank and pay the visa application fee (provide your visa approval email)
2. Obtain accident and health insurance certificates from insurance offices operating at the airport (if you do not own a valid international insurance certificate)
3. Go to e-visa counters No. 1 or 2 to proceed with the visa issuance procedure

**Passengers who have not applied through [evisa.mfa.ir](http://evisa.mfa.ir) and who request visas on arrival**

**Upon arrival at the airport, go through the following steps:**

1. Obtain a visa application form from the passenger guide in the lounge and fill out the form (incomplete forms will be returned)
2. Obtain a ticket from the queue management system, wait in the lounge for your interview, and go to the visa counter No. 3 in your turn
3. Go to the airport bank to pay the application fee
4. Obtain accident and health insurance certificates from the insurance offices operating at the airport (if you do not own a valid international insurance certificate)
5. Submit your passport and bank receipt (red slip) to counter No. 3 to proceed with the visa issuance procedure

**Note: It is recommended that the above applicants apply electronically for visas in their future trips through the [evisa.mga.ir](http://evisa.mga.ir) website in order to facilitate and minimize the time of the process of obtaining the Islamic Republic of Iran's visa.**
